

# Idaho Cost Information

The cost information below has been extracted from the “Rule H Line Installation Tariffs”. Copies are also available by contacting Idaho Power or the Idaho Public Utilities Commission.

## General Service Requirements

Electrical facilities provided by the customer must be properly grounded, electrically and structurally safe, provide adequate clearances, and be ready for connection.

The customer must obtain all permits required by the applicable state, county, or municipal governments before calling Idaho Power and provide copies or verification, as required.

The site must be inspected, if required, and all conditions must be met before the service will be connected.

## Underground Permanent Service (400 amp maximum)

The non-refundable charge for a new underground 1-Ø service consists of a Base Charge plus a Distance Charge. These charges do not apply to services with meter bases larger than 400 amps.

Charges for installation of underground service are not included in Cost Quotes and are billed to the customers after construction is complete.

### Base Charge

From underground.....	\$23.00
From overhead (2" pole riser).....	\$599.00
From overhead (3" pole riser).....	\$873.00

### Distance Charge (Customer trench & conduit)

With 1/0 service cable .....	\$3.34/ft
With 4/0 service cable .....	\$4.01/ft
With 350 service cable .....	\$5.45/ft

Use the following Distance Charges if Idaho Power provides the trench and conduit:

### Distance Charge (IPCo trench & conduit)

With 1/0 cable.....	\$9.52/ft
With 4/0 cable.....	\$10.19/ft
With 350 cable.....	\$12.43/ft

**NOTE.** There may also be additional charges for unusual trenching conditions.

## Temporary Service Charges

The non-refundable charge for installing a 1-Ø temporary service is:

From <u>underground</u> .....	\$59.00
The customer-provided meter pole must be securely set within 2' of the handhole or padmounted transformer.	
From <u>overhead</u> .....	\$247.00
The customer-provided meter pole must be securely set in a location that will allow the temporary service conductor to be attached to the permanent meter location by merely relocating it. A maximum of 100' of #2 Tx conductor is allowed.	

## Return Trip Charge

Each installation is subject to review and inspection at any time by Idaho Power for conformance to these specifications.

If a non-conformance is discovered such as the conduit length, route, depth, etc., or if you are not ready when the installation crew arrives, the cable **will not be installed** and **you will be charged** for each return trip.

After the non-conformance is corrected, contact Idaho Power to reschedule the installation.

Underground Temporary Service .....	\$59.00
Overhead Temporary Service .....	\$59.00
