With approximately \$1 million in annual giving and thousands of hours of service and volunteerism, it's clear Idaho Power employees care deeply for their communities. Our company proudly supports dozens of charitable causes — including one recent donation that hits especially close to home.

Regional Manager Brent Lulloff and Program Specialist Shawn Lovewell are part of a group that oversees the distribution of corporate contributions and Employee Community Funds (ECF). As their teams considered charities this year, they noticed an opportunity to support an organization whose mission is dear to the hearts of many at Idaho Power: the Leukemia and Lymphoma Society (LLS).



"LLS is a great organization, and with so many ties to our Idaho Power family, we felt it was a perfect opportunity to give back and help people in our community whose lives are touched by these diseases." Lulloff said.

Idaho Power employee Steve Floyd, a Key Account Energy Advisor, has been managing a leukemia diagnosis since 2015. In recent years, he has lost several close friends to cancer, including fellow employee Steve Petrie and retiree Dave Matlock. Their wives, Dana Petrie and Patty Matlock, remain close members of the Idaho Power family, and Dana is a fundraiser for LLS.

"Idaho Power has been awesome in its support of LLS," Floyd said. "Surviving cancer is an ongoing battle, and one of the wonderful things about LLS is that it's constantly on the leading edge of clinical trials. When I relapsed in 2019, I took part in a procedure that was considered experimental at the time. It saved my life, so I'm incredibly grateful to LLS."

With so many employees, family members and friends impacted by leukemia and lymphoma,

Lulloff and Lovewell decided to combine their funds and award LLS \$5,400 to support the local chapter and its annual Light the Night fundraiser. Brent and Shawn were joined by Steve, Dana, Patty and others as Idaho Power delivered its donation to LLS Development Managers Lexie Lamothe and Adan Callsen in downtown Boise.

"I just feel so blessed, not only because our company supports cancer research, but also for the invaluable health benefits we receive, and for the great employees who contribute to ECF in support of organizations like LLS and employees like me," Floyd said. "I have to thank LLS, Idaho Power and my fellow employees, because without them, I wouldn't be here."

Bringing an AED to the Cambridge Senior Center

Seniors in a rural Idaho community received access to a potentially life-saving medical tool when Idaho Power donated an automated external defibrillator (AED) to the Cambridge Senior Center — one of several AEDs our company has given to small towns where

emergency response times can be longer and hospitals aren't always nearby.

"Safety is so important at Idaho Power, not only for our employees but also for our customers and the communities where we live and work," said Residential and Commercial Energy Advisor Dani Rollins. "We're happy this donation will help keep seniors in the Cambridge and Midvale communities a little safer."

Helping Idaho Youth Ranch Serve Neighbors in Need

The Idaho Youth Ranch needed an assist this summer after a fire destroyed its Treasure Valley warehouse. Idaho Power stepped up with donations totaling \$6,500, supporting the annual Unite for Hope Gala and other urgent program needs. The money will help Idaho Youth Ranch staff continue providing Treasure Valley neighbors in need with emergency shelter, residential care, family therapy, job readiness training, adoption services, youth programs and a network of thrift stores.

Celebrating 40 Years of Community Support



As you look to give back this holiday season, consider helping neighbors in need by donating to Project Share.

Project Share is a year-round bill-pay assistance program started by Idaho Power in 1982 and managed through The Salvation Army and local outreach offices throughout southern Idaho and eastern Oregon. One hundred percent of Idaho Power customer donations go to Project Share recipients. The assistance is available to supplement energy needs and can be applied to bills for electric and gas. The program can also help pay for heating materials like wood, propane, oil and coal.

You can donate to Project Share by:

- Setting an amount to add to each month's bill
- Donating the difference between your monthly amount due and the nearest dollar
- Donating a set amount plus the difference between the amount due and the nearest dollar each month
